1. There is no refund for the early return of the instrument.

2. We guarantee the instrument to play well. We will repair or replace any defective instrument. In the event of a problem, call us. **Do not** try to fix the instrument yourself. We will repair to good playing condition all defects in the instrument which arise from normal use. This guarantee does not apply to accidental, excessive, or deliberate damage, or to normal deterioration of appearance such as finish deterioration, scratches, and minor dents. Also excluded from this guarantee are drumheads, sticks, strings, and other expendable accessories such as reeds, rosin, oil, grease, swabs, and mouthpieces.

3. The lessee is responsible for the return of the instrument in the same condition as it was received, except for normal wear. Any damage done during the lease period, whether caused by the lessee or by some other person, is the responsibility of the lessee.

4. The lessee is responsible for the timely return of the instrument. If the instrument is returned after the expiration date, a \$5.00 late charge per month plus a daily charge based on current lease rates will be assessed.

5. The lease may be terminated by returning the instrument to Black Horse Music, Inc., or to the child's school if the instrument was picked up at the school. If returning instrument to child's school, please notify the store in advance. Any outstanding charges are due at the time the instrument is returned.

6. **DEFAULT:** Ownership of the instrument remains with Black Horse Music, Inc. until the instrument is paid in full. If the lessee defaults on any scheduled payment, Black Horse Music, Inc. may cancel this agreement and repossess the instrument wherever located, in school or elsewhere. A \$25 fee will be charged if repossession is necessary. If legal proceedings are necessary to recover an instrument or rental fees incurred, the lessee will be responsible to pay the reasonable attorney's fees incurred by Black Horse Music, Inc.

7. Black Horse Music, Inc. will partially waive damage to an instrument caused by fire, theft or accident (but not willful damage) for an additional fee, shown below.

Coverage exists only in the case of accidental damage, residence fire, or burglary of home, of which there shall be visible evidence of forced entry, which must be reported to local police station within 24 hours. Payment of deductible and a copy of the police report must be submitted to Black Horse Music, Inc. promptly, along with written request for replacement. The replacement coverage is limited to one occurrence only. Loss from an unlocked building is not covered, nor is loss in any school or public building. Mysterious disappearance is not covered. (For example, loss by negligence, such as forgetting instrument on street corner, bus, playground, etc.)

Excluded from coverage are drumheads, sticks, strings, and other expendable accessories such as reeds, rosin, oil, grease, swabs, and mouthpieces.

8. If the lessee wishes to purchase a new instrument during the term of the lease, Black Horse Music, Inc. will sell to lessee a new instrument of like kind or comparable quality at a discount price plus tax if applicable.
